



## GENERAL PROVISIONS

The World Percheron Futurity is an incentive program for owners of Percheron horses registered with the Percheron Horse Association of America and/or the Canadian Percheron Horse Association and exhibited at the World Percheron Congress, Des Moines, Iowa.

### ELIGIBILITY – WEANLING FOAL:

- 1) In order to participate in the Futurity, unborn foals must be nominated by December 31, 2017.  
A completed World Percheron Futurity Application, nomination fee of \$100 and copy of the dam's registration paper must be on file with the Futurity Secretary by December 31, 2017 for each foal to be nominated for participation in the Futurity. The Futurity rights of the mare are for the upcoming foaling year and cannot be postponed to a different year under any circumstance.
- 2) A copy of the registration papers for the nominated foal must be on file with the Futurity Secretary by July 1. No pending registrations will be accepted.  
If the foal's registration papers are not on file by July 1, it will become ineligible for future participation in the Futurity unless a reinstatement penalty of \$100 is paid.
- 3) In the event of a sale of the bred mare and/or nominated foal, eligibility for the current year is transferable to the new owner. It is the responsibility of the new owner to provide an updated copy of the foal's registration papers to the Futurity Secretary prior to July 1.
- 4) Entrants must meet and comply with all entry and exhibitor requirements of the World Percheron Congress as listed in the premium Entries.

### FUTURITY CLASSES AND PURSES

- 1) The World Percheron Futurity classes will be held at the World Percheron Congress, Des Moines, Iowa. Classes offered will be as follows:
  - **World Percheron Futurity Senior Filly Foal (Foals born Before March 15, 2018)**
  - **World Percheron Futurity Junior Filly Foal (Foals born after March 16, 2018)**
  - **World Percheron Futurity Senior Stallion Foal ( Foals born before March 15, 2018)**
  - **World Percheron Futurity Junior Stallion Foal (Foals born after March 16, 2018)**

**Supreme foal will be chosen from the first place foal of all four classes**
- 2) Horses participating in the World Percheron Futurity classes may also enter the open classes.
- 3) Futurity class entries must be made on the official World Percheron entry form. There are no entry fees for the Futurity classes other than the \$100 entry fees. The exhibitor will be responsible for any stalling, admission, parking or other related expenses administered by the World Percheron Congress.
- 4) The 3 official judges will be the used in futurity class.
- 5) The Futurity purses will be awarded to the individual(s) listed as the owner of the nominated foal on file with the Futurity secretary – no exceptions allowed. The World Percheron Futurity will not be responsible for any ownership disputes.
- 6) The first place foal in each filly and each stallion Futurities classes are guaranteed a sponsored \$1,250 purse. Purses for foals placing second through tenth will be paid a percentage of the additional sponsorships, nomination and related fees collected. A preliminary premium schedule is printed below for all 4 classes. This schedule may be adjusted based on sponsorships. 10% of the nomination and related fees will be retained by the Futurity for use in defraying office expenses.
  - **1st: \$1,250**
  - **2nd: 7.5%**
  - **3rd: 5%**
  - **4-6th: 2%**

• **7-10th: 1%**

**OTHER**

- 1) Deadline dates listed are determined by postmark date (i.e. Dec 31th). Postage meters are not considered valid postmarks.
- 2) There will be absolutely no refunds of nomination or related fees. No exceptions.
- 3) A service charge of \$25 will be required for a returned check. Failure to pay this service charge and honor the check within 30 days of notification will result in disqualification without recourse of the nominations or related fees covered by that check.
- 4) Protests related to parentage verification or similar complaints will be handled in accordance with the World Percheron congress.

**FUTURITY DEADLINES**

***December 31, 2017:***

- Application, nomination fee and copy of dam's registration papers must be on file for 2018 foal.

***July 1, 2018:***

- A copy of the registration paper for the 2018 foal must be on file. Foals without registration papers on file become ineligible and can only be reinstated through payment of penalty.
- Official World Percheron congress entry must be done online or mailed entries to the Percheron Horse Association Office.
